Honored Sir, I F A B A D ,

Today i.e., on 02.08.2021 at 0900 hrs., the complainant Nikkore Nagesh, S/o.Chandu, age 26 yrs, caste: Barey, Occ: Agril, R/o. Ippalnageaon village of Asifabad Mandal came to PS and lodged a Telugu written complaint in which he stated that he is having agricultural land at the outskirts of Ippalnageaon village and this year also cultivating cotton crop. Yesterday i.e. on 01.08.2021 as usual he came to attend agricultural work at his field and morning at about 11.00 hrs., on person proceeding on motor cycle B.No.AP25AJ 0653 from Asifabad side to Wankidi side and when he reached near Saleguda X road, all of sudden one car B.No.MH34AM 3941 which coming from Wankidi to Asifabad, the car driver drove the car in rash and negligence manner and hit the motor cycle in opposite direction and proceeded without stopping car towards Asifabad. Immediately the complainant rushed there and found injured person on the road and the injured received bleeding injuries on his fore head and right leg and on enquiry he came to know the injured particulars i.e. his name Mesram Nagesh, S/o. Arju, R/o. Keslapur village of Indravelli Mandal. Later called 108 ambulance and shifted the injured to Govt. Hospital Asifabad and after he came to know that the injured referred to Mancherial for better treatment. Due to not available of family members of the injured he came to PS as eye witness and lodged petition. The petitioner request to take necessary action against the car driver who droved rash and negligence manner and hit the motor cycle.
